



## **REFUND POLICY**

- $\rightarrow$  Entries open on **12<sup>th</sup> December 2023.**
- $\rightarrow$  Entries will close on **12<sup>th</sup> February 2024.**
- $\rightarrow$  Accepted cars publication by 1<sup>st</sup> March 2024.

## Withdrawal of a Competitor Application

FROM: Opening date of entries  $\rightarrow$  TO: Closing date of entries

Return of the **amount paid net of deduction of € 200.00** plus VAT 22%.

FROM: The day following the closing date for entries  $\rightarrow$  TO: Friday 1<sup>st</sup> March 2024 (Accepted cars publication)

Return of the amount paid net of a **penalty of € 1,250.00** (not subject to VAT pursuant to article 15(1) of Presidential Decree 633/72).

FROM: The day following the publication of accepted cars  $\rightarrow$  TO: Wednesday 24<sup>th</sup> April 2024

Return of the amount paid net of a deduction equal to 50% of amount paid plus VAT 22%.

FROM: Thursday 25<sup>th</sup> April 2024  $\rightarrow$  TO: Thursday 16<sup>th</sup> May 2024

Return of the amount paid net of a deduction equal to 75% of the amount paid plus VAT 22%.

FROM: Friday 17<sup>th</sup> May 2024

The entry fee shall not be refunded.



## Cancellation or suspension of the event due to force mejeure

FROM: Opening date of entries  $\rightarrow$  TO: Closing date of entries

The amount paid will be **refunded in full to the competitor.** 

FROM: The day following the closing date of entries  $\rightarrow$  TO: Friday 3<sup>rd</sup> May 2024

Return of the **amount paid net of a deduction of € 250.00** plus VAT 22%.

FROM: Saturday 4<sup>th</sup> May 2024  $\rightarrow$  TO: Friday 24<sup>th</sup> May 2024

Return of the amount paid net of a deduction equal to 10% of the amount paid plus VAT 22%.

FROM: Saturday 25<sup>th</sup> May 2024  $\rightarrow$  TO: Sunday 2<sup>nd</sup> June 2024

Return of the amount paid net of a deduction equal to 20% of the amount paid plus VAT 22%.

FROM: Monday 3<sup>rd</sup> June 2024  $\rightarrow$  TO: Saturday 8<sup>th</sup> June 2024

Return of the amount paid net of a deduction equal to 50% of the amount paid plus VAT 22%.

FROM: Sunday 9<sup>th</sup> June 2024
