

FAQ Sporting Licenses

Drivers must hold the following documents in order to carry out the administrative checks.

All files can be uploaded in the reserved area by 15th of May and the originals must be brought to the Paddock.

Italian Drivers

- **Identity document** (front and back) valid for the entire duration of the race;
- **Driving licence** (front and back) valid for the entire duration of the race;
- **Sporting licence** valid for the entire duration of the race;
- **Medical certificate** for non-competitive sporting activity stamped and signed by a doctor and valid, with indication of ECG date;
- **Vehicle Registration certificate** (front and back);
- Any **declaration that the vehicle does not require a periodic inspection** according to the laws of the country where the vehicle is registered
- **Vehicle insurance** valid for the entire duration of the event;
- Vehicles belonging to **OLDTIMER Group** and to **YOUNGTIMER Group** built up to **31.12.1990** must also be accompanied by one of the following valid sporting documents: ACI-CSAI Regularity of Historic Cars card/ HTP FIA (Historic Technical Passport FIA)/ HTP CSAI (Historic Technical Passport CSAI)/ Certificate of registration to ACI Storico Register/ ASI homologation or identity certificate/ Certificate of registration to the AAVS National Historic Register/ FIA historic car regularity pass/ FIVA Identity Card.

Foreign Drivers

- **Identity document** (front and back) valid for the entire duration of the race;
- **Driving licence** (front and back) valid for the entire duration of the race;
- Drivers with a non-EU national driving licence must hold an **international driving licence** (front and back) valid in Italy;
- **International sporting licence** or **national sporting license with VISA** issued by the NSA;
- **Medical certificate** for non-competitive sporting activity. The document must be produced in English
- **Vehicle registration certificate** (front and back);
- Any **declaration that the vehicle does not require a periodic inspection** according to the laws of the country where the vehicle is registered
- **Vehicle insurance** valid for the entire duration of the event;
- Vehicles belonging to **OLDTIMER Group** and to **YOUNGTIMER Group** built up to **31.12.1990** must also be accompanied by one of the following valid sporting documents: ACI-CSAI Regularity of Historic Cars card/ HTP FIA (Historic Technical Passport FIA)/ HTP CSAI (Historic Technical Passport CSAI)/ Certificate of registration to ACI Storico Register/ ASI homologation or identity certificate/ Certificate of registration to the AAVS National Historic Register/ FIA historic car regularity pass/ FIVA Identity Card.

Sporting License for foreign Drivers

For drivers with foreign residence with no sporting license, it is possible to apply for a temporary Italian licence. In order to make this request, besides the papers listed above, the following documents must be uploaded in the reserved area:

- Self-declaration of non-possession of other licences;
- Authorization to 1000 Miglia Srl to request the document at the Automobile Club of Brescia

The temporary licence issuing service has a cost of € 240 VAT included for each document requested
